3. A 'Sensitive Interest' is an interest which could create or is likely to create a serious risk that you or a person connected with you may be subjected to violence or intimidation.
4. Where the interest is no longer a 'Sensitive Interest' you must notify the Monitoring Officer within 28 days of that change.
5. Reference to Member is taken to include an elected or co-opted member to the Council.
6. West Berkshire Council's Monitoring Officer is required to ensure that a copy of the Council's Register of Members Interests is both available for inspection and also that the Register is published on its website.
