

# Minutes of a meeting of Cold Ash Parish Council on Tuesday 13<sup>th</sup> February 2024 at 7pm in the Committee Room of Acland Memorial Hall

- PublicA member of the public spoke to raise an objection to agenda item 239410 AParticipation23/02856/REG3 Land Midway Between Heath Lane and Southend and Opposite, Cold<br/>Ash Hill. He said that the gate proposed to be replaced by this application has not been<br/>used in the 25 years he has been resident in Cold Ash. A gateway on Hatchgate Close<br/>has been regularly used to access the land (JW concurred with this statement as a<br/>resident of Hatchgate Close) and he questioned why a new gate is needed. He also<br/>stated that he believes agricultural access is permitted via the new gateway to the<br/>catchment ponds rendering another new gateway unnecessary. He is concerned that<br/>the addition of another gateway onto Cold Ash Hill would be a way of opening the site to<br/>future development for housing.

### 239410 **Planning Matters**

### **A** Applications

23/02856/REG3 Land Midway Between Heath Lane and Southend and Opposite, Cold Ash Hill Construction of a new agricultural access point to the landowner's field to replace the existing one that is to be lost as a result of the Flood Alleviation Scheme currently under construction at Heath Lane (ref. 21/03135/COMIND). The works will involve the removal of the existing gate used for access and the provision of a 4.8m wide new gate access point, and grasscrete surface to provide a crossing point from the existing kerb line to the existing field.

**RESOLVED** ALL IN FAVOUR TO OBJECT: Cold Ash Parish Council objects to the construction of a new gate. The gate, which is proposed to be replaced due to its loss as a result of the Flood Alleviation Scheme, has been left unused for many years in favour of an alternative access point via Hatchgate Close. This Council believes that a new gate is unjustified.
